Safer Woking Partnership Plan 2025 to 2028

Community Safety Partnerships are statutory multi-agency groups that were established by the Crime and Disorder Act 1998. In Woking this is the Safer Woking Partnership SWP.

The purpose is to work together to tackle crime and disorder and anti-social behaviour in the Woking area and make communities feel safer.

The statutory members are:

- NHS Surrey Heartlands Integrated Care Board
- Surrey County Council
- Surrey Fire and Rescue Service
- Surrey Police
- Probation Service
- Woking Borough Council

In addition we work closely with the Police and Crime Commissioner's Office, local voluntary sector organisations and with the local community.

Each year, following an assessment, we develop priority areas that the partnership will focus on which are then published as our Partnership Plan.

Aims

The Safer Woking Partnership has the following aims:

- To identify, protect and support the most vulnerable people and areas in our communities, and tackle offenders who are involved in criminal and/or anti-social behaviour.
- To promote crime prevention to maintain the low levels of crime and disorder.
- To promote reassurance:
 - to involve the public and work with all communities to reduce the fear of crime and provide people with a sense of safety and reassurance.
 - to improve education/knowledge for the public to support their own feelings of safety.

The partnership will:

- Work jointly with other statutory and voluntary agencies.
- Build capacity within the neighbourhoods and communities to enable them to contribute to the delivery of the aims of this plan.

Surrey Police data

Surrey Police has provided some key data which has been used when considering the priorities for the partnership plan.

Data such as crime statistics, heat maps and surveys can be good indicators to understand trends, concerns and areas of vulnerability. However, statistics alone are difficult to be used and require further analysis to understand them. For example, if increases in stop searches occur the partnership will need to consider what else is happening in that area. If police receive more fraud offences being reported to them is this a result of awareness campaigns?

Using data from the past three years, Operation Chariot identified areas (hotspots) with the highest levels of ASB and serious violence. An area in Woking town centre was deemed to be one of 15 hotspots across Surrey. Officers patrol these hotspots daily, supported by Safer Neighbourhood Teams and other local resources.

By increasing the number of police patrolling a defined area it is likely to have an impact where more crimes will be 'discovered' in these areas. These may not have been previously found or reported.

Snapshot of crime data 2023 to 2024

Data in Woking:

- Overall crime: There was a 5.5% fall in reported crime in Woking between 2023 and 2024.
- Domestic abuse crime: There was a 13% drop in reported domestic abuse recorded crimes.
- Hate crime: There was an 8% increase in hate crime.

This data is similar across the whole of surrey:

- Overall crime: 3.1% drop
- Domestic abuse: 7% drop in recorded crimes
- Hate crime: 6% increase

This overall approach to looking at a range of data, and local knowledge and experience, ensures that our plan is future proofed and captures both national and local priorities to enable us to effectively address crime and anti-social behaviour in the Woking area.

The partnership will be reviewing data and information across agencies to develop some baseline data to help measure success and changes. This will also help with strategic needs assessments for future partnership plans.

Priorities for 2025 to 2028

Reducing community harm and anti-social behaviour (ASB)

Making it easier for victims of anti-social behaviour to report and feel they are supported and issues are addressed to prevent escalation.

Fraud

Established partnership delivery mechanism

- JAG: The Joint Action Group (JAG) is a multi-agency problem solving group which deals with problem locations in the borough and meets every six or seven weeks. They consider issues including antisocial behaviour, rough sleeping and arson.
- SOC JAG: This is a meeting that discusses problem areas related to Serious Organised Crime (SOC), such as County Lines, cuckooing, modern slavery and human trafficking. It meets every six or seven weeks before JAG.
- CHaRMM: The Community Harm and Risk Management meeting (CHaRMM) is a multiagency problem solving group which supports victims and deals with problem individuals or families in the borough and meets on a monthly basis.
- MAPPA: Multi Agency Public Protection Agreement meets monthly and monitors dangerous individuals, including sex offenders.
- MARAC: Multi Agency Risk Assessment Conference where high risk domestic abuse cases are assessed and appropriate actions agreed on a monthly basis.
- RMM: Risk Management Meeting meets weekly to monitor and risk assess missing and exploited children.
- Surrey Youth Offending Family Support To work with Targeted Youth Support/Surrey Youth Offending Service in successfully managing the transition of young adult offenders into the adult Probation system.
- MASH: The Surrey Multi Agency Safeguarding Hub (MASH) is the initial point of contact that aims to improve the safeguarding response for children and adults at risk of abuse or neglect through better information sharing and high-quality and timely responses.

- MEAM Making Every Adult Matter this is called SAM Surrey Adult Matters our local version of the making every adult matter. This is a wraparound support service for those people with multiple disadvantage, not just for those with criminal convictions; but here there is often a significant overlap.
- Domestic Abuse Management Board meets quarterly and oversees county wide domestic abuse work, including any campaigns.
- The Family Support Programme provides intensive assistance through a dedicated family coordinator who collaborates with each family member to gain an understanding of the family dynamics as well as their individual hopes and aspirations and needs.
- Surrey Family Safeguarding team Probation specialist domestic abuse workers will
 work alongside mental health and substance misuse workers in this team. To engage in
 work with these three key issues of mental health, substance misuse and domestic
 abuse including with families who are not in the criminal justice system.
- Youth Engagement Scheme (YES) run by Surrey Fire and Rescue Service, which is aimed at addressing anti-social behaviour, youth crime, low self-esteem and low motivation for those aged 14-17.
- Firewise Scheme run by Surrey Fire and Rescue Service which offers counselling for juvenile fire setters.
- Voluntary organisation networks, such as Woking Neighbourhood Watch, Residents Associations and Woking Street Angels.
