## How to Pay Your Council Tax and How To Contact Us

### APPLY ONLINE

You can apply for discounts, exemptions, set up Direct Debit payments, request to pay your Council Tax over 12 monthly instalments, request a payment arrangement, request a refund or notify us of a change or when you move home, and make payments via our online forms which can be found on our website [www.woking.gov.uk](http://www.woking.gov.uk)

### PAYMENTS

#### 1. BY DIRECT DEBIT



Direct Debit is the easy and convenient way to pay giving you the choice of three payment dates (**1st, 10th or 20th of each month**) so you can pick a date which suits you best. If you do not currently pay by this method and wish to do so, you can make arrangements online at [www.woking.gov.uk](http://www.woking.gov.uk). Be ready to enter the details (sort code and account number) of your bank or building society account from which payments will be collected along with your Council Tax payment reference number.

#### 2. ONLINE

You can pay through our website using your Visa, MasterCard, Switch or Delta card. Please ensure that you quote the correct payment reference as shown on your bill. If you wish to pay by this method please log onto our website [www.woking.gov.uk](http://www.woking.gov.uk) and click on "Council Tax" under the "Pay" heading.

#### 3. HOME BANKING

You can use the home banking service provided by your bank or building society to pay. Please ensure you quote the payment reference, which is shown on your bill. Payments should be made to Lloyds Bank Plc, sort code 30-00-00, account number 03393755, for the credit of Woking Borough Council.

#### 4. AUTOMATED TELEPHONE PAYMENTS

You can make a debit or credit card payment at any time 7 days a week by calling us on 01483 755855 and selecting option 1 "To make a payment". Please make sure that you have your credit or debit card to hand, along with your Council Tax payment reference number, which can be found on your bill.

#### 5. BY STANDING ORDER

You will need to contact your bank directly to pay by this method. If you have previously notified us that you pay by standing order, a new mandate will be sent to you with your next annual bill. If you have recently started paying by this method please let us know by emailing [ctax@woking.gov.uk](mailto:ctax@woking.gov.uk)

### PAYMENT DATES

Payments must be received no later than the date(s) shown on your bill. If payments are received after the due dates your account will be in arrears. If you would like to make payments after the 1st of the month you can do so by paying by Direct Debit. Instalment dates of the 1st, 10th or 20th of the month are available to Direct Debit payers. You can apply to pay by Direct Debit online at [www.woking.gov.uk](http://www.woking.gov.uk).
