



NOTICE IS HEREBY GIVEN that the Borough Council has received applications for Planning Permission, Conservation Area Consent, Listed Building Consent, potential Departure, Major Development or which may affect a Public Right of Way or for works to trees in a Conservation Area or covered by a Tree Preservation Order, as the case may be, for developments as briefly described in the following schedule:

**Roundbridge Farm Cottages, Old Woking Road, Woking. PLAN/2020/0064/BRB:** Erection of 8 x two storey dwellings and associated access, parking and landscaping.

**\*Rear of 69 Old Woking Road, West Byfleet. PLAN/2020/0195/BRC:** Erection of a rear dormer.

**Pyrford Place, Pyrford Road, Woking. PLAN/2020/0202/BRC:** Erection of two storey boathouse following demolition of existing boathouse, refurbishment of existing footbridge and erection of single storey storage building and associated works.

**\*Great Barn, Sutton Park, Sutton Green, Guildford. PLAN/2020/0215/BRB:** Proposed replacement of windows in rear elevation from white powder coated painted aluminium to grey powder coated painted aluminium and replacement of front gate.

**Great Barn, Sutton Park, Sutton Green, Guildford. PLAN/2020/0216/BRB:** Listed Building Consent for proposed replacement of windows in rear elevation from white powder coated painted aluminium to grey powder coated painted aluminium and replacement of front gate.

**\*10 Gorselands Close, West Byfleet. PLAN/2020/0218/JK:** Erection of a single storey side and rear extension following demolition of existing extension.

**\*1 Poundfield Gardens, Old Woking, Woking. PLAN/2020/0253/BRC:** Erection of a first floor rear extension, hip-to-gable roof extension, insertion of front and side facing rooflights, erection of front porch and external alterations.

**Flat 37 Chertsey Road, Woking. PLAN/2020/0254/BRB:** Retrospective application for the change of use to HMO (House of Multiple Occupancy) for 10 persons (Sui Generis).

**\*1 Roundbridge Farm Cottages, Old Woking Road, Woking. PLAN/2020/0267/BRB:** Erection of two storey extension to north elevation following demolition of existing single storey extension and internal alterations.

**1 Roundbridge Cottages, Old Woking Road, Woking. PLAN/2020/0268/BRB:** Listed Building Consent for erection of two storey extension to north elevation following demolition of existing single storey extension and internal alterations.

**\*Grey Walls, Hook Heath Road, Woking. PLAN/2020/0277/JK:** Demolition of potting sheds, existing boiler room, existing extension and non-original chimney. Construction of ground floor rear extension, reinstatement of rear/side access door, insertion of 1 x roof window.

**\*St Michaels, Ashwood Road, Woking. PLAN/2020/0293/CB:** Erection of single storey rear extension and 1no. rear dormer, 1no. side dormer and 2no. rooflights.

**\*1 Roundbridge Farm Cottages, Old Woking Road, Woking. PLAN/2020/0267/BRB:** Erection of two storey extension to north elevation following demolition of existing single storey extension and internal alterations.

**Land Adj Hoe Valley Stream West of Smarts Heath Lane, Woking. PLAN/2020/0274/WF:** Proposed retention of existing boundary treatment and access (retrospective).
