

ROAD TRAFFIC REGULATONS ACT 1984 – SECTION 14

WOKING BOROUGH COUNCIL (LOCKE WAY No.1) (TEMPORARY ROAD CLOSURE) ORDER 2019

NOTICE of a proposal to make a temporary traffic regulation order under section 14(1) of the Road Traffic Regulation Act 1984 (RTRA 1984) and regulation 3 of the Road Traffic (Temporary Restrictions) Procedure Regulations 1992 (SI 1992/1215)

WOKING BOROUGH COUNCIL

- 1. WOKING BOROUGH COUNCIL as agent for SURREY COUNTY COUNCIL (being the Highway Authority) gives notice that it proposes to make an Order under section 14(1) of the RTRA 1984 and any other enabling powers over (i) an area of the highway being Locke Way, Woking shown coloured RED on the plan attached to the Order ("Plan"); and (ii) temporary two way traffic along accessed section of Locke Way shown coloured YELLOW on the Plan; and (iii) reversing the flow of traffic along part of Dukes Street between Locke Way and Maybury Road junctions respectively shown coloured BLUE on the Plan.
- 2. The Order will:

- (i) close one part of an area of the highway known as Locke Way shown coloured RED on the Plan;
- (ii) impose two way traffic along the second part of Locke Way shown coloured YELLOW on the Plan; and
 (iii) impose a contraflow system along part of Dukes Street
- shown coloured BLUE on the Plan.

 The Order is needed to facilitate resurfacing of part of Locke Way using block paving to match the paving used within the town
- 4. If the Order is made, the Order shall come into operation on 15 April 2019 at 00.01am for a period of 6 WEEKS.
- 5. An alternative access route will be available for use while the Order is in force. From Maybury Road turn right into Dukes Street, turn left at the junction of Locke Way to access Addison. The exit route will be turn left at Dukes Street and turn right onto Chertsey Road following the one way system.
- 6. Access for pedestrians will be maintained at all times.
- 7. A copy of the draft Order and Plan may be inspected free of charge at Woking Borough Council, Civic Offices, Gloucester Square, Woking, Surrey GU21 6YL from 15 April 2019 until 17 May 2019 between the hours of 9.30am to 4pm, Monday to Friday (excluding bank holidays and public holidays).
