



**ROAD TRAFFIC REGULATIONS ACT 1984 – SECTION 14
WOKING BOROUGH COUNCIL (LOCKE WAY No.2)
(TEMPORARY ROAD CLOSURE) ORDER 2019**

Notice of a proposal to make a temporary traffic regulation order under section 14(1) of the Road Traffic Regulation Act 1984 and regulation 3 of the Road Traffic (Temporary Restrictions) Procedure Regulations 1992 (SI 1992/1215)

1. WOKING BOROUGH COUNCIL as agent for SURREY COUNTY COUNCIL (being the Highway Authority) gives notice that it proposes to make an Order under section 14(1) of the RTRA 1984 and any other enabling powers over (i) an area of the highway being Locke Way, Woking shown RED on the plan attached to the Order ("Plan"); and (ii) temporary two way traffic along accessed section of Locke Way shown coloured yellow on the Plan; and (iii) reversing the flow of traffic along part of Dukes Street between Locke Way and Maybury Road junctions respectively shown coloured blue on the Plan.
2. The Order will:
 - (i) close one part of an area of the highway known as Locke Way shown coloured red on the Plan; and
 - (ii) impose two way traffic along the second part of Locke Way shown coloured yellow on the Plan; and
 - (iii) impose a contraflow system along part of Dukes Street shown coloured blue on the Plan.
3. The Order is needed to facilitate resurfacing of part of Locke Way using block paving to match the paving used within the town centre.
4. If the Order is made, the Order shall come into operation on 27 May 2019 at 12.01am for a period of six weeks.
5. The Order will (i) restrict vehicular access to the north section of Locke Way, Woking, shown in RED on the Plan, and (ii) allow two way traffic along the south section of Locke Way shown coloured yellow on the Plan, and (iii) allow a contraflow system along part of Dukes Street shown coloured blue on the Plan, in the direction indicated in green arrows on the Plan, from 27 May 2019 to 8 July 2019.
6. An alternative access route will be available for use while the Order is in force. The Broadway turn right into Locke Way to access Addison Road. The exit route will be turn right at Broadway junction and turn right onto Chertsey Road following the one way system.
7. Access for pedestrians will be maintained at all times.
8. A copy of the draft Order and Plan may be inspected free of charge at Woking Borough Council, Civic Offices, Gloucester Square, Woking, Surrey GU21 6YL from 27 May 2019 until 8 July 2019 between 9.30am to 4.45pm, Monday to Friday (excluding bank holidays and public holidays).
