

Woking Borough Council (Locke Way No.2) (Temporary Road Closure) ORDER 2019 Woking Borough Council as agent for Surrey County Council (being

- the Highway Authority) gives notice that it has made an Order under section 14(1) of the RTRA 1984 and any other enabling powers over (i) an area of highway being Locke Way, Woking shown hatched red on the Plan attached to the Order; (ii) temporary two way traffic along

 - the accessed section of Locke Way shown coloured yellow on the
 - Plan attached to the Order; and (iii) reversing the flow of traffic along part of Dukes Street between the Locke Way and Maybury Road junctions respectively shown coloured blue on the Plan attached to the Order.
- 2. The Order: (i) closes one part of an area of the highway known as Locke Way
 - shown coloured red on the Plan attached to the Order; (ii) imposes two way traffic along the second part of Locke Way
- shown coloured yellow on the Plan attached to the Order; and imposes a contraflow system along part of Dukes Street shown (iii) coloured blue on the Plan attached to the Order. 3. The Order is needed to facilitate resurfacing of part of Locke Way
 - using block paving to match the paving used within the town centre. The Order commenced on 27 May 2019 at 12.01am for a period of six weeks. The duration of the Order can be extended with the
- approval of the Secretary of State for Transport. 5. The Order (i) restricts vehicular access to the north section of Locke Way, Woking, shown in red on the Plan attached to the Order, and (ii) allows two way traffic along the south section of Locke Way
 - shown coloured yellow on the Plan attached to the Order, and (iii) allows a contraflow system along part of Dukes Street shown coloured blue on the Plan attached to the Order, in the direction indicated in green arrows on the Plan, from 27 May 2019 to 8 July 2019.
 - An alternative access route is available for use while the Order is in force. At The Broadway turn right into Locke Way to access Addison Road. The exit route will be turn right at Broadway junction and turn
 - right onto Chertsey Road following the one way system. Access for pedestrians will be maintained at all times.
