Proposed Prohibition of Vehicles
in Church Street East, Church Path and Christchurch Way (D3662) Woking

SURREY COUNTY COUNCIL propose to make the Surrey County Council Church Street East Church Path and Christchurch Way (D3662) Woking (Prohibition of Traffic) Order 202-, under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), the effect of which will be to prohibit motor vehicles from entering or proceeding in (1) Church Street East (D3662) Woking from a point 4.5 metres east of the eastern building line of No. 4 Church Street East to its south-westernmost extent; (2) Church Path (D3662) Woking, from its junction with Church Street East southwards for approximately 50m to the end of the carriageway; and (3) Christchurch Way (D3662) Woking from its junction with Church Street East north-westwards for a distance of 18 metres.

The proposed prohibition will not apply to (a) vehicles for the purpose of access to properties within the restricted area including for the purpose of loading and unloading goods; (b) Ambulance, fire brigade or police vehicles in an emergency; (c) Anything done with the permission or on the direction a police constable in uniform or a sign placed by the Police; (d) anyone riding a pedal cycle or invalid carriage; (e) Where necessary in connection with works on any sewer, gas, water, electricity or telecommunications system; (f) In the service of a local authority or water authority in pursuance of statutory powers or duties; (g) Post Office vehicles for the purpose of their functions; (h) By holders of permits issued by the traffic authority or its agents; (f) or anything done with the written authorisation of the Traffic Authority or its agents.

The existing one-way restriction in Church Street East (between Chobham Road and Christchurch Way), Christchurch Way and Chobham Road (between Christchurch Way and Church Street East), Woking, will be revoked.
