Proposed Prohibition of Vehicles
in Commercial Way and Chobham Road (D3662), Woking

SURREY COUNTY COUNCIL propose to make the Surrey County Council Commercial Way and Chobham Road (D3662) Woking (Prohibition of Motor Vehicles) Order 202-, under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), the effect of which will be to prohibit motor vehicles from entering or proceeding in (1) Chobham Road (D3662), Woking, from its junction with Commercial Way to its junction with Chertsey Road; and (2) Commercial Way (D3662), Woking, from its junction with Church Path to its junction with Chobham Road. The proposed prohibition will not apply to (a) vehicles for the purpose of access to properties within the restricted area, including access for the purpose of loading and unloading goods; (b) Ambulance, fire brigade or police vehicles in an emergency; (c) Anything done with the permission or on the direction a police constable in uniform or a sign placed by the Police; (d) anyone riding a pedal cycle or invalid carriage; (e) Where necessary in connection with works on any sewer, gas, water, electricity or telecommunications system; (f) In the service of a local authority or water authority in pursuance of statutory powers or duties; (g) Post Office vehicles for the purpose of their functions; (h) By holders of permits issued by the traffic authority or its agents; (f) or anything done with the written authorisation of the Traffic Authority or its agents.

The Borough Council of Woking (Woking Town Centre) (Traffic Regulation) Order 1994, will be amended so as to revoke the prohibition of traffic relating to the lengths of roads specified above.
