

ROAD TRAFFIC REGULATONS ACT 1984 – SECTION 14

(CHERTSEY ROAD - SECTION BETWEEN CHOBHAM ROAD and THE BROADWAY) (TEMPORARY ROAD CLOSURE) ORDER 2021

Notice of a proposal to make a temporary traffic regulation order under section 14(1) of the Road Traffic Regulation Act 1984 and regulation 3 of the Road Traffic (Temporary Restrictions) Procedure Regulations 1992 (SI 1992/1215).

- 1. WOKING BOROUGH COUNCIL as agent for SURREY COUNTY COUNCIL (being the Highway Authority) gives notice that it proposes to make an Order under section 14(1) of the RTRA 1984 and any other enabling powers over (i) an area of the highway being Chertsey Road, section between Chobham Road and The Broadway, Woking shown BLUE on the plan attached to the Order ("Plan").
- 2. The Order will:
 - (i) close one part of an area of the highway known as Chertsey Road shown coloured BLUE on the Plan
 - (ii) impose temporary traffic light shown RED on the Plan
 - (iii) impose a temporary two way traffic along the section of Chertsey Road between Chobham Road and Dukes Street shown coloured YELLOW on the plan.
- 3. The Order is needed to facilitate resurfacing of part of Chertsey Road using block paving to match the paving used within the town centre.
- 4. If the Order is made, the Order shall come into operation on 4 January 2021 starting at 10am for a period of 8 weeks.
- 5. The Order will restrict vehicular access to a section of Chertsey Road, Woking, shown in BLUE on the Plan.
- 6. An alternative access route will be available for use to access and exit Chertsey Road and Chobham Road while the Order is in force. The access will be from The Broadway turn right into Locke Way, turn left into Dukes Street, and turn right into Chertsey Road / Chobham Road shown GREEN on the Plan.
- 8. Access for pedestrians will be maintained at all times.
- 9. A copy of the draft Order and Plan may be inspected at the public notice board outside the main entrance to Woking Borough Council, Civic Offices, Gloucester Square, Woking, Surrey GU21 6YL from 21 December 2020 for a period of 6 months. A copy may also be viewed by visiting www.woking.gov.uk
